ARTICLE: 10.2.2

270 hours per school year

**(C) WHAT DO I NEED TO KNOW ABOUT PARENT
CONFERENCES?**

ARTICLE 6.20.1 Parent/teacher collaboration shall be compensated for nine (9) hours salary as reflected in Article 18.

(D) PROCESS TO BE DOCKED PAY

ARTICLE: 7.18.4 Prior to a teacher being docked pay for any reason, the District shall conduct an audit of the teacher's leave entitlement and inform the teacher of his/her entitlement and the proposed docking.

**(E) DO THE 20 DAYS TO GIVE A NOTICE OF
EVALUATION START FRESH FOR A CHANGE OF
ASSIGNMENT?**

ARTICLE 3.3.1: d. In the event of a late hiring or change of assignment, the meeting may be specially scheduled and shall occur within twenty (20) working days after the date of the late hire or change of assignment.

**(O) HOW MANY DAYS DOES THE DISTRICT HAVE
UNTIL THEY HAVE TO START PAYING OVERRAGES?**

ARTICLE 2.4.1: At the beginning of the school year, the District will have thirteen (13) instructional days to make adjustments without paying any overage payments.

(G) TIMELINE TO FILE A GRIEVANCE

ARTICLE 5.2.2.1 The grievance shall be filed in writing no later than fifteen (15) work days after the aggrieved person knew or should have known about the occurrence.

**(PreK) SHOULD PREK TEACHERS ATTEND
FACULTY MEETINGS?**

ARTICLE 12.10.1.d Meetings: District PreK teachers shall not be required to attend the regular school faculty meetings.

(E) CAN YOU MEMBERS USE DISTRICT EMAIL?

ARTICLE 14.2.3 Association Use of District Email

The Association and its members may utilize District email to communicate during non work time. The email communications must comport with the District's acceptable use policy.

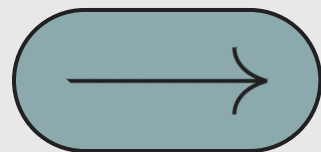
